

Disclosure of transparency notifications

(Article 14 of the Law of 2 May 2007 on the disclosure of significant shareholdings in listed companies)

bpost discloses a notification of significant shareholdings that it has received from BlackRock, Inc (and affiliates) in accordance with the Belgian Law of 2 May 2007 on the disclosure of significant shareholdings in listed companies.

1. <u>Summary of the notification</u>

In a notification of June 22, 2017, BlackRock, Inc., also on behalf of its subsidiaries set forth in the notification, notified that, following a disposal of bpost voting securities or bpost voting rights, it decreased its holding and it crossed downward the 3% threshold of voting rights in bpost on June 21, 2017.
